

General Information Text on Protection and Processing of Personal Data

Your personal data may be processed by Tersan Shipyard Information Systems Industry and Trade Joint Stock Company ("Tersan Shipyard" or "Company") as explained below in accordance with the Law on the Protection of Personal Data numbered 6698 ("KVKK").

1. Method of Collection and Legal Basis of Personal Data

Your personal data may be processed and transferred within the scope of the purposes specified in this Information Text, in accordance with the fundamental principles envisaged by the KVKK and the personal data processing conditions and purposes specified in Articles 5 and 6 of the KVKK.

- Determining, planning, and implementing the short, medium, and long-term commercial policies of Tersan Shipyard,
- Designing and conducting human resources activities of Tersan Shipyard,
- Supporting the design, planning, and execution of human resources activities of our Company,
- Ensuring the commercial and legal security of Tersan Shipyard, its affiliates, and the individuals within business relations,
- Preserving the commercial reputation and trust created by our Company.

3. Transfer of Your Personal Data and Its Reasons

- Ensuring the commercial and legal security of Tersan Shipyard, its affiliates, and the individuals within business relations,
- Preserving the commercial reputation and trust created by our Company.

IV. Your Rights as Data Subject under Article 11 of the KVKK

The rights of individuals whose personal data is processed under Article 11 of the KVKK are as follows:

- Learning whether personal data is processed,
- Requesting information if personal data has been processed,
- Learning the purpose of processing personal data and whether they are used appropriately for that purpose,
- Knowing the third parties to whom personal data is transferred domestically or abroad,
- Requesting correction of personal data if it is incomplete or incorrectly processed and requesting notification of the transaction made within this scope to third parties to whom personal data has been transferred,
- Requesting deletion or destruction of personal data in case the reasons requiring processing cease to exist despite being processed in accordance with the KVKK and other relevant laws, and requesting notification of the transaction made within this scope to third parties to whom personal data has been transferred,
- Objecting to the occurrence of a result against the individual by exclusively analyzing the processed data through automated systems,
- Requesting compensation for damages in case of suffering damage due to the unlawful processing of personal data.

Our Company will conclude your request as soon as possible and within a maximum of thirty (30) days free of charge depending on the nature of the request. However, if the transaction requires additional costs, a fee specified in the tariff determined by the Personal Data Protection Board will be charged.
